Rotary Foundation District Grants

- Simple, flexible, innovative
- Educational and humanitarian projects and activities consistent with mission
- Smaller activities and projects
- Local decision making with broader guidelines



Funding Attributes

District Grants

- Initiated by clubs and district
- Follows TRF Mission, preferably within the six areas of focus
- Preference for International projects in developing countries
- Local and DDF funding only, no World Fund match
- Up to \$4,000 grant, club matches \$ for \$
- One grant per club, but clubs can work together on a project



Examples

District Grants — Mission-related

- International travel for local doctor to volunteer at a clinic
- Project in non-Pilot Districts such as D4100 in Mexico
- Community Service Project
- Rotarians At Work Day project
- Others?



Application Process

District Grants

- Complete online form
 - President, President-elect, Project Chair sign
- District Grants Chair reviews and seeks additional information if required
- District Grants Subcommittee prioritizes projects based on merit and available funds
- District Grants Chair presents list to Foundation Committee for approval
- Clubs are notified
- Checks are delivered
- Club performs project
- Club provides final report with receipts and photos

Rotary Foundation Global Grants

- Long-term projects
- Rotarian participation
- Larger grant awards
- Minimum project size is \$30,000
- Sustainable, measurable outcomes
- Must be within the six areas of focus
- International partnerships required



District-Developed Global Grants

- Developed based on long-term or developing relationships
- In development
 - District 9200 East Africa
 - Uganda Adopt a Village
 - Kenya Water Project
 - District 9270 South Africa
 - District 3000 India
 - District 4400 Ecuador



Club-Developed Global Grants

- Developed by qualified clubs
- Projects with Future Vision Pilot Districts only
- DDF, World Fund, cash flow through
- Maximum of \$12,000 in DDF available with \$6,000 from club
- Awards will be based on merit and available funds
- Minimum grant of \$15,000 from TRF World Fund
- Streamlined stewardship and accountability

Club Qualification

- Clubs must be qualified to participate in a Global Grant
- Ensures proper legal, financial, and stewardship controls of grants
- Club Qualification process is simple
 - At least one club member attends the Grants Management Seminar (recommend more)
 - Club President-elect, Foundation Chair, International Service Chair, Community Service Chair, others
 - Club President reads, understands and signs the Memo of Understanding

- March 20, District Assembly (am) & Grants
 Management Seminar (pm)
- May 1, Final Due Date for ALL Grants submissions
- May 31, District and Global Grants Identified,
 Global Grants finalized for submission on July

District Grants

- Select a Project
- Work with Foundation Mentor and District Grants Chair to complete application
- Attend the Grants Management Seminar
- Submit paperwork by May 1



What to Do Now

Global Grants

- Select a Project
 - District-Developed Grant
 - Club-Developed Grant
- Work with Foundation Mentor and Global Grants
 Chair to complete proposal and application
- Attend the Grants Management Seminar
- Complete Qualification
- Submit proposals by May 1



Timeline – Preparing for Future Vision

Preparation Year 2009-2010

- Organize District team
- Receive training and guidelines from TRF
- Train and qualify the Clubs
- Clubs prepare District Grant applications
- Clubs/District prepare Global Grant proposals and applications



Timeline – Year 1

Pilot Phase 2010-11

- Begin awarding grants to pilot districts
- Update on pilot to Trustees
- Last year to fund some current programs (non-Future Vision Districts)
- Modify and improve for year 2



Timeline – Year 2

Pilot Phase 2011-12

- Continue awarding grants to pilot Districts
- Evaluation of pilot successes and challenges
- Final pilot evaluation to Trustees
- Make necessary modifications



Timeline – Year 3

Pilot Phase 2012-13

- Continue awarding grants to pilot Districts
- Final pilot evaluation
- Adjust grant model for full rollout
- Qualify and train all Districts



Timeline – Full Rollout

Full Rollout 2013-14
